Vice-Presidents Report*By Paul Bilotta Vice-President*

This will be my last newsletter as Vice President. I have enjoyed serving our membership as Vice President and Grievance Chair. To say the last several years have gone fast would be an understatement. To say we have overcome many obstacles would be an even bigger understatement. Our members have worked with us tirelessly to ensure that our contractual rights are maintained through the grievance process as well as the arbitration process.

Negotiations have been underway since the expiration of the contract. Meetings were being held regularly until the Chief Labor Negotiator for the city resigned. When that happened our meetings stopped until a new person was put in place to fill that job. We have resumed meetings with some regularity and will continue to do so. I would like to thank you for your patience during this tedious process.

Our next general meeting is Thursday January 18 at 1800. It would be great to see meeting attendance increase. We hold six meetings per year. The meeting schedule is as follows: 18 January Annual Meeting at 1800 Hours, 15 March General Meeting at 1200 Hours, 17 May General Meeting at 1800 Hours, 19 July General Meeting at 1200 Hours, 20 September General Meeting at 1800 Hours (Home Run Inn Pizza/Awards Dinner), 15 November, General Meeting at 1200 Hours (Thanksgiving Raffle). We also have our Corned Beef and Cabbage retirement dinner in February at St. Ignatius College Prep. This dinner will be held on February 15 at 1800 hours. I realize everyone has busy schedules. I urge all of you to try to commit to attending one meeting this year and learning more about your association.

I have been asked by several members to explain the Binding Summary opinion process. This process is used primarily for suspension cases. If you receive a suspension of 10 days or less your case would be eligible to proceed to Binding Summary Opinion. This process involves the city and the union agreeing on an arbitrator. Once that has been done the city will send their investigation to the arbitrator. The union is allowed to send a one page brief explaining their perception of the investigation. This may involve issues such as timeliness, interviews, witnesses, circumstances, etc. Once an arbitrator has everyone's paperwork submitted to them they will begin review of the case. We have begun setting time limits on arbitrators as of late asking that they have a decision to us within 30 days of receiving the case unless there may be an extenuating circumstance. This process has worked very well and most if not all members that have utilized it have been satisfied with the outcome. We have had people talk about wins and losses. That topic is subjective. One person

Pension Report*By Brian Wright Pension Board Representative*

2017 treated us great!! The fund had an investment return of 16.33% as of November 30th, 2017. That was 4.45% above the policy benchmark of 11.88%. This coupled with payments from the City of \$449 million allowed us to increase our assets from \$2.40 billion on 12/19/16 to \$2.66 billion on 11/30/17. The increase of \$260 million amounted to a total increase of 10% of the fund's value.

The City owed us \$464 million per the statute and paid us \$449 million. The \$15 million we are shorted is because the City was shorted. The City pays us with their receipt of the tax levy. So when people do not pay their taxes, the City does not pay us that same amount. As those taxes come in later, we will receive them. There is no telling how much of the \$15 million we will eventually receive or when we will receive it since it comes in sporadically. This year the City is obligated to pay us \$500 million per the statute.

Approximately \$62 million per month is paid out in annuity payments, disability payments, refunds, death benefits and administrative costs. This totals \$744 million that walks out the door every year. This amount will only increase over time which is why the City's contributions will as well, until we are 90% funded.

But what we must realize is that we cannot invest our way out of this hole. We just had a GREAT year and only increased our assets 10%. We need more money coming in from the City, as the statute dictates, to ensure we get the most from a good year like 2017. The more money in the fund the more it grows with a 16.33% return. Membership contributions is not enough either. Even if we were to increase our contribution percentage (from 9%) or bolster our ranks (currently at 12,500 contributing on 12/15/17) it is not enough. Every little bit helps, but we cannot contribute ourselves out of the hole either.

The ONLY answer to a continued and consistent increase in the value and funded ratio of this fund is the steady increasing contributions from the City. Now, if we could only get some sort of dedicated funding source that could help out with the contribution from the City.....hint hint.....Casino.....

getting a 10 day suspension that has it reduced to 3 days would certainly consider that a win with that decision. Another person getting a 10 day suspension and getting it reduced to 3 days would consider it loss because they still had a three day suspension. I remind everyone that the opinion is binding and that the arbitrator saw fit as an independent third party to either impose penalty or dismiss the penalty altogether. Whatever the outcome may be it is the fairest opportunity anyone will have regarding discipline in a suspension case.

Thank you for all that you do, and remember, take care of each other.

As of this writing there are 1207 members in the 9171 pay code. The budgeted strength for our pay code is 1272 which leaves us 65 sergeants short at this time.

Law Enforcement Gun Liability Coverage

Overzealous prosecutors can bring criminal charges against you. Protecting your freedom is costly and time consuming. Our policy provides you with Criminal Defense Reimbursement benefits if you are criminally charged and those charges are subsequently dismissed, or you are acquitted of criminal charges related to your use of a firearm in an act of self-defense.

MOONLIGHTING

Our policy will provide coverage for Civil Liability, Defense Costs and Criminal Defense Reimbursement Coverage for the use of your firearm when working as an independent contractor providing security protection in a capacity other than law enforcement.

EXCESS FIREARM LIABILITY COVERAGE

Our policy will provide Civil Liability, Defense Costs and Criminal Defense Reimbursement Coverage for the use of your firearm in a law enforcement act. Coverage is on an excess basis, when no other coverage is available to you, or other coverage has been disclaimed.

District / Field Representative Program

The District / Field Representative (Rep) program shall consist of twenty-four (24) sergeants that are willing to take an active part in the association. Reps will share information from the association with bargaining unit members, serve on committees at the discretion of the President, and be eligible to be appointed delegates to conferences of the association.

District / Field Representatives will be appointed by the President or elected within their assigned / detailed unit(s) of representation if more than one Sergeant is interested / eligible to serve. If a Rep is transferred, detailed for more than ninety days, or retires during a term, the President may appoint another Sergeant to serve out the term of the outgoing Rep. Reps will be compensated for their participation in the program after attending at least one half of the six (6) general meetings of the association with a rebate of one half of the sergeants' annual dues payable in February of the following calendar year.

Food for Thought*By Rabbi Moshe Wolf - Chaplain*

Recently, before we had the great Marathon in our city, one of our members "Johnny" walked into my office and asked me "Rabbi, should I run the marathon"? So I asked him, "Why do you want to run the marathon"? He answered me "Because at the end of the Marathon, I can drink all the beer that my heart desires". Then I asked him, "Why don't you want to run the marathon"? He answered me, "Look at me, I am 63 years old and never ran a marathon in my life". I told him "go for it and do the best you can". At the end he managed to run 10 miles. I don't know about you, but that is a serious run even for somebody who is experienced. Two weeks after the marathon, Johnny calls me and he says, "Rabbi, can we meet? I need to talk". So we made up to meet, and it ended up being one of the most inspirational moments that I've ever had. I walked into the coffee shop and Johnny was sitting there waiting for me and he had tears in his eyes. He said, "Thank you for encouraging me to run the marathon. I never realized it was going to be a life-changing experience". He continued "Rabbi, please let me share with you what I learned from this experience. As I was running the race I realized, that not all of us are going to reach the finish line, but that does not mean that we shouldn't try. Then I looked toward the starting line and realized that there are some people running the race in wheelchairs, some while wearing prosthesis, and there was actually someone that I noticed on crutches. Making me realize that some of us are better equipped to run than others but that didn't seem to hold them back from running the race. As I was running I looked over my shoulder and I noticed about a block behind me was a gentleman in a wheelchair without legs and he was pushing himself with a device made to work with his hands. I was thinking to myself that this man in the wheelchair would give anything to have a pair of legs, yet that did not hold them back from being part of the race. I was totally inspired and encouraged by his determination. I also could not help noticing the people along the route who were cheering us along. I did not know any of them but I was quite inspired by their cheering, smiling and voices telling us not to quit. I ran as long as I could, until my body physically could not go any longer. That night when I came home I sat down with a pen and paper, to write down my feelings of the moment. I was thinking to myself, I ran the marathon but it actually was a lesson of a lifetime, and the title I wrote on my paper was "Running the Marathon of Life".

"Isn't it the same for all of us as we go through this path called life? We all enter the race, some make it to the end faster than others. Some are better equipped to run than others but that shouldn't hold us back from running. And if you ever feel like you need to stop running, look over your shoulder to those less fortunate than you are, who would give anything to be in your place. Every so often we need to pause in life and take stock of what we have and thank G-d for it and be grateful, as opposed to being depressed or upset on what we don't have. And another big lesson that I have learned is that in life sometimes the biggest act of kindness that one can do for another is even from the sidelines, is a kind word, a smile and some words of encouragement. There are those moments in life when we are shown more than we can understand, never underestimate "just being there" for others."

We chatted for a bit longer, shared a few laughs and parted ways. It will be a morning that I will long remember. What a powerful lesson to carry with us, that it is okay for us to enjoy life, even though things might not be as perfect as we hoped for. It reminded me of the story
