I would like to now welcome and congratulate the 99 new Sergeants that received their stripes this month, you can see all those promoted on page 8 of this edition of Chevrons. To the new Sergeants, you will be a welcomed sight in the Districts. For all those who are fortunate enough to get a few of the new Sergeants, give them a helping hand in their transition. We were all the new guy, or girl, at one point in time or another. They received the academy teaching of how to be a Sergeant, now they need the street education of how to be a good supervisor. Treat them well and it will pay off for all. I would also like to congratulate the 44 new Lieutenants that were also promoted this month. The old Sergeant list is most likely gone and any future promotions will be off the new list. I hope they get another large class in soon as we are once again greatly understaffed both as per the budget and were it matters, on the street.

Consent Decree Section VIII. Supervision C. Staffing, Allocation, And Deployment 2. Unity Of Command and Span Of Control Pages 103-104 Paragraph 365. By January 31, 2022, CPD will fully implement and maintain a staffing model that achieves unity of command and a span of control ratio of no more than ten Officers to one Sergeant for all field units on each watch in each of CPD's patrol districts. To achieve this objective, CPD will maintain, at a minimum, one Sergeant for each sector. That seems pretty simple 10 Officers for 1 Sergeant; right? Well not in this Department. With that being said, it has come to my attention that there are Districts once again with one Sergeant working the street. I have set up a dedicated email for ...Continues on page 10

Vice President's Report By Vice President Danielle Barnes

The past couple of years have been very challenging for our members and the Department. We began this unfortunate journey in the early part of 2020 when the COVID-19 Pandemic began, coupled with unprecedented riots and civil unrest in our city. It's 2022 and I don't think any of us imagined we would still be in the midst of a pandemic and continuing to lose members and retirees to this illness. Our membership has been subjected to less than ideal working conditions throughout this process. RDO cancellations unfortunately have become the norm for our department. As we approach the end our contract which expires on 30 June 2022, it is important that we start prioritizing the issues that are of the utmost importance to the membership. The current language in our collective bargaining agreement doesn't do enough to protect the health and overall wellbeing of the membership. It permits the Department to cancel RDO's without regard to the negative impact it can have on its members.

I believe RDO cancellations is one of the key issues that must be addressed in the next contract. We reached a settlement agreement with Department in regards to the process of cancelling RDO's but it was for specific holidays (Memorial Day, Juneteenth, Fourth of July, & Labor Day). We believe the Department continues to violate the spirit of that agreement. As a result we continue to file grievances for all RDO cancellations. Additionally, we scheduled two hearing dates in February with Arbitrator Roumell who has jurisdiction over the settlement agreement. We are hopeful that some measures will be put in place to protect the wellbeing of the membership. Nonetheless this is definitely one of the keys issues that must be prioritized for the next contract. Please share any ideas or suggestions that you have with Jim or I. It is important that we get feedback from the membership. Please share other issues that are of critical importance for the next contract negotiations.

As always, please take care, stay safe and thanks for the opportunity to continue serving the membership.



this, whenever you see a Sergeant supervising over the Consent Decree mandated maximum ratio of 10:1 please <u>scan</u> the sheet(s) and email them to <u>staffing@chicagosergeants.org</u>. I ask you not to send screenshots or pictures as sometimes they are not easily viewed on the email. All the Districts have a printer/copier capable of scanning and emailing. If you don't know how I'm sure there is someone who can assist. Thank you in advance. Hopefully with the new Sergeants hitting the streets on the 16th, we won't see any more of the 1 Sergeant to 25 Officers that has happened so often in the past.

The Lieutenant exam Part 1 is scheduled for February with Part 2 in March, I wish all those that are taking it good luck, and for those fortunate to get promoted, please don't forget where you came from. For those wondering how many signed up and payed the fee, it is 800 +/- a few. That is a large number as there were fewer than 1200 Sergeants at the time of registration.

We still do not have a date that the Me-Too retro check from the FOP contract will be paid. As soon as I get any info I will be sure to pass it on. To those Members that were promoted after July 2017, you received part of your retro. Any retro that you earned after promotion will be on a separate check. And please remember retro checks are taxed at a different rate than regular checks, most will have a higher tax rate. For those Members that retired and are due a retro check it will be mailed USPS certified mail to the address that the Department has on file. If you retired and moved ensure the Department has your current address. *Checks cannot be picked up in person instead of being mailed.*

It appears a few politicians are now having second thoughts on the "police reform bill" that was slammed through last year. Maybe now they will realize the Police are not the problem and start to pass real legislation that combats the violence we are unfortunately seeing on a daily basis. Election Results

The Pension Fund recently held an election for two of the trustee positions. I would like to congratulate Mike Lappe on his re-election as the Retiree representative and welcome Wayne Metcalfe as the newly elected representative for active members below the rank of Sergeant. Wayne Metcalfe's election means the position of Fund President, previously held by Tom Beyna, is unfilled at this time.

At last month's board meeting, Mike Lappe and I nominated Mike Stiscak, the Lieutenants' representative, as the new president of the Fund. Wayne Metcalfe and I also nominated Mike Lappe to continue in his role as the Vice President of the fund. However, as the city trustees nominated fellow city trustee Stephen Skardon, to each of those positions, the votes for each position were deadlocked. Each of the police trustees voted for Stiscak and Lappe, while each of the city trustees voted for Skardon. I expect that another vote will be cast at the upcoming meeting and I will be sure to update all of you with the results. I believe it is important to have actual fund participants in these positions. Trustee Skardon has served the Fund well, but as city trustees come and go with no consequence, the financial future of each police trustee is tied to the health of the Fund for the rest of their lives, and often their families' lives beyond that. As such, I think it makes perfect sense that those positions should be held by active participants, the stakeholders of the Fund. The pension Fund was not properly funded by the city for decades, thereby creating the situation in which we currently find ourselves. It would be foolish to not do everything we can to hold the city accountable.

In 2021, the Fund gained 676 new retirees who have begun collecting an annuity. By comparison, the Fund saw 560 retirees in 2020 and 475 retirees in 2019. These numbers are historic highs and I expect that trend will continue. It is no surprise that we are seeing so many people leave the department as police are constantly demonized in the media and shortsighted changes in law and policy are instituted that further serve to make the career of a police officer so difficult to navigate. That's why it is so important for us to work together to insure that our Fund is properly looked after. I encourage everyone to visit the Fund's website at chipabf.org where you can find the latest news affecting the Fund, past years' audits, actuarial valuations, and financial reports. You can also find the Participant Handbook which is a well-organized and informative reference source for the Fund's participants.

As for the city's contributions for 2021, as of December, the fund had received \$712,578,000 of the city's required contribution of \$737,527,000, resulting in an outstanding liability of \$24,949,000, or approximately 3.4% of their outstanding liability. That percentage is in line with the amount of total city contributions that were outstanding as of this date last year. We expect that we will receive the remainder of the contributions in the first quarter of 2022. However, in the event that the remainder of the money is not received by that time, the Fund intends to file to intercept state funds if in accordance with Illinois Pension Code 40 ILCS 5/5 -168.

The United American plan is eligible for the pension subsidy and the Public Safety Officer Federal tax deduction. We also offer Blue Cross Individual plans for those spouses who are not Medicare eligible.

Over 65 and never enrolled in Medicare because you did not have enough Quarters? Everyone can join Medicare and pay an extra premium, even if they do not have 40 Quarters. The Medicare General Enrollment Period starts January 1st and ends March 31st. Once enrolled, your Medicare coverage will be effective on July 1st. CPSA's 2022 Scholarship
