Many of you are wondering how the Contract negotiating is doing. Right now we are on pause until the new Mayor is chosen. The Board has taken what you, the Membership, have informed us as the most important issues, and those will be the priority in negotiations. As we get some information I will push it out to everyone.

We have a few Members who currently are or in a very short period of time, will be in a no-pay status. We are accepting donations for them, you may select the Member(s) you wish your donation benefits, or to have it evenly split among all of the Members currently in no-pay. Please contact the office if you would like to contribute. On behalf of those Members, Thank You.

For those of you contemplating retirement please do your due diligence BEFORE pushing the button. Make the calls, do your calculations, and have a game plan for your post CPD life. Some of the calls you need to make are the Pension Board (probably the most important), deferred comp, benefits office, and possibly a retirement financial advisor. If you will be retiring with Retiree Health Care from the City, it will take several weeks to get your new policy card. Your last day of employment is the last day you are covered in the City's active plan. The group number for your policy changes once retired, which means if your healthcare provider submits a bill for services performed after you retire and uses your old info the bill will be denied. It's not that you don't have coverage it's just that they used incorrect info. Please, if you have any questions call the office and we can go over some of the general issues and point you in the right direction for answers we can not give you.

Now on to an issue that seems to change as frequently as the sun rises. Birthdate restriction removal for the pension 3% COLA. I have been told so many times that it looks good, then to be told nope it's dead, my head hurts. 3% COLA is something that all Members should be granted. Some of the reasons I have heard for us not receiving it are asinine, to say the least. Hopefully, the legislators in Springfield get in the correct mindset and finally get the COLA bill passed.

St Jude will be Sunday, May 7th at Gold Star Memorial Park. I like to thank all those that plan to come out in support of our Fallen Brothers and Sisters In Blue. This year's DC Candlelight Vigil will be on Saturday, May 13th and the Capital Ceremony will be on Monday, May 15th. Retired Sergeant Al Piantkowski has once again produced an excellent guide for attending this year's DC ceremonies. It is posted on our website, chicagosergeants.org. For those that have never attended, it is something that can not be expressed in just words. If at all possible everyone should attempt to attend at least once in their career.

Over the last several months there have been several changes to the Association's Bylaws. The updated Bylaws will soon be available on our website. The Chicago Police Sergeants' Association Board elections take place later this year. The Election Chairman Retired Sergeant Don Januszyk proposed a few changes to the Bylaws that deal with the election timelines. I advise everyone to check the website to familiarize themselves with the Bylaws.

Vice President's Report

As a result of the COVID-19 Pandemic, there is a backlog of grievances. We are only allowed to schedule two (2) arbitrations per month. We currently have one hundred and forty (140) open grievances. There are twenty-one (21) medical grievances. Thirteen (13) of them have settlements that are pending implementation. There are thirty-four (34) grievances with suspensions between eleven (11) to three hundred and sixty-five (365) days. Of those grievances, nine (9) are for suspensions of eleven (11) to thirty (30) days, nine (9) are for sixty (60) days, four (4) are for ninety (90) days, ten (10) are between one hundred and twenty (120) days to one hundred and eighty (180) days, and two (2) are for three hundred and sixty-five (365) days. Seven (7) of those grievances are set for arbitration or have an award pending. There are twenty-one (21) suspension grievances of ten (10) days or less. Six (6) have been sent to arbitrators and the awards are pending.

All COVID-related grievances are on hold until we exhaust the appeals process for the COVID-19 policy mandate implemented by the City. Unfortunately, the Illinois Supreme Court denied our appeal and will not hear our case. The next step is to have a hearing before the Illinois Labor Board. This hearing is set for July 10th and July 11th. I am happy to report that we have several arbitrations scheduled for this year including the FOP Me-Too Grievances for active and retiree healthcare. They are scheduled for July 14th and August 24th with Arbitrator Brennwald. If anyone would like an update on the status of their grievance please give me a call to discuss.

In addition to the golf outing fundraiser, we are hosting the 87th Annual Police Benevolent & Protective Association Convention October 6-8, 2023 at the Embassy Suites 5500 N. River Road in Rosemont, IL. We are anticipating there will be many officers and their guests from across the state in attendance. We are seeking volunteers to assist with activities during the convention as well as donations for raffle prizes. There are also many sponsorship opportunities available. If you would like to donate, volunteer or want more information about sponsorship opportunities please give me a call or send me an email.

Food for Thought

"MAKING MUSIC WITH WHAT YOU'VE GOT" Compliments of Rabbi Moshe Wolf

Did you ever notice there are some people who show up for work always in a good mood and always ready to share a laugh, and then there are those who walk around looking like they are carrying the weight of the world? Recently while attending a roll call, I was standing at the door of the room, handing out some sweets, and this Officer walk in with a big smile, very well-kept. His uniform was just right, clean, well pressed and all his equipment was just right. We chatted a bit, and I asked the Officer "what is the secret to the great attitude?" He said, "Rabbi sometimes you have to make music with what you have left". And he continued "Let me tell you the story".... "Making Music With What You Have Left"

On Nov. 18, 1995, Itzhak Perlman, the famous violinist, came on stage to give a concert at Lincoln Center in New York City. If you have ever been to a Perlman concert, you know that getting on stage is no small achievement for him. He was stricken with polio as a child and has braces on both legs and walks with the aid of two crutches. To see him walk across the stage one step at a time, painfully and slowly is a sight. He walks painfully, yet majestically, until he reaches his chair. Then he sits down, slowly, put his crutches on the floor, undoes the clasps on his legs, tucks one foot back, and extends the other foot forward. Then he bends down and picks up his violin, puts it under his chin, nods to the conductor, and proceeds to play. By now, the audience is used to this ritual. They sit quietly while he makes his way across the stage to his chair. They remained silent while he undoes the clasps on his legs, they wait until he is ready to play. But this time, something went wrong. Just as he finished the first few bars, one of the strings on his violin broke. You could hear it snap - it went off like gunfire across the room. There was no mistaking what he had to do. People who were there that night thought to themselves: "We figured that he would have to get up. put on the clasps again, pick up the crutches and limp his way off the stage - to either find another violin or else find another string for this one. Or wait for someone to bring him another." But he didn't. Instead, he waited a moment, closed his eyes, and then signaled the conductor to begin again. The orchestra began, and he played from where he had left off. And he played with such passion and such power and such purity, as they had never heard before. Of course, anyone knows that it is impossible to play a symphonic work with just three strings. I know that you know that. But that night Itzhak Perlman refused to know that. You could see him modulating, changing, and recomposing the piece in his head. At one point it sounded like he was de-tuning the strings to get new sounds from them that they had never made before. When he finished, there was an awesome silence in the room. And then people rose and cheered. There was an extraordinary outburst of applause from every corner of the auditorium. Everyone was on their feet, screaming and cheering, doing everything they could to show how much they appreciated what he had done. He smiled, wiped the sweat from his brow, and raised his bow to guiet the audience, not boastfully, but in a quiet reverent tone: "YOU KNOW, SOMETIMES IT IS THE ARTIST'S TASK TO FIND OUT HOW MUCH MUSIC YOU CAN STILL MAKE WITH WHAT YOU HAVE LEFT." What a powerful line that is. And who knows? Perhaps that is the way of life - not just for an artist but for all of us. Here is a man who has prepared all his life to make music on a violin with four strings, who all of a sudden, in the middle of a concert, finds himself with only three strings and the music he made that night with just three strings was more beautiful, more sacred, more memorable, than any that had ever made before, when he had four strings. So perhaps our task in this shaky, fast-changing, bewildering world in which we live, is to make music, at first with all that we have, and then when that is no longer possible, to make music with what we have left. We are living in an era faced with many challenges, political, financial, and emotional, where so much has changed, let us stop for a moment and think about how we can make beautiful music with what we ... History Of The Chicago Police Sergeants' Association Collective Bargaining By... Past President Ret Sgt Bob Kirchner

In the last article (Chevrons January 2023), I explained how the collective Supervisor's Associations fought to obtain collective bargaining rights. Now I'll explain how the PBPA was chosen to represent Supervisors but first I must add a fact I forgot to add to the last article.

When the Supervisor's Associations presented their case to the Illinois Labor Board, Lt Jim O'Neal put on a fantastic presentation. He and the other Associations convinced the Late Mayor Jane Byrne to go to Springfield and testify on behalf of Supervisors having the right to collective bargaining. This was a HUGE deal and helped the Supervisors cause tremendously.

After being dealt a devastating blow by the FOP denying the Supervisors' request to have their own lodge, the heads of the Associations met and planned their next move. Lt Jim O'Neal related he was aware of the PBPA of Illinois, and personally knew the current President of the Illinois PBPA. With this information, the Presidents of the collective Supervisor's Associations decided to contact the Illinois PBPA and inquire about representation for Supervisors. Lt O'Neal called Jim Graham, then the President of the Illinois PBPA. As Lt O'Neal began explaining his position about the PBPA representing Supervisors, President Graham was riding in a vehicle with Mr. Sean Smoot, legal counsel of the PBPA of Illinois. Mr. Smoot explained what needed to be done and Lt O'Neal informed the heads of the other Associations. Time was of the essence. The collective Associations had to obtain signatures of all 30% of their respective Associations in order to petition the city for an election. At this point, the President of the Captain's Association backed out and did not want to join the PBPA. However, there were less than 40 Captains on the Police Department at that time, and getting 30% to sign up for a collective bargaining unit was not a problem.

At a meeting, the President of the Chicago Police Sergeants' Association explained the 30% signature requirement. These signatures needed to be obtained and returned to the Association in a matter of days. This Herculean task was accomplished and the City was petitioned for an election. This stunned the leadership of the FOP 7 lodge who did not expect the Associations to seek out a different organization for collective bargaining rights.

Next Issue: The election results.


Retiree Info

Important Retirement Milestones: Ages 62, 65 and 73 By Mike Marron

Age 62: Should I wait to collect Social Security? In retirement, there are certain milestones which require some choices. Most Americans elect to start reduced Social Security benefits at Age 62. The public sector retiree also must be aware of the Windfall Elimination Provision and the Government Pension Offset Provision. Please call Mike to discuss the pros and cons of waiting to collect your Social Security Retirement benefits.

Are you turning 65 soon? Everyone needs to activate their Medicare coverage. If you are still under the Chicago retiree health coverage through your spouse, you need to enroll in Medicare at 65, to avoid any possible late Medicare enrollment penalties. The City plan then becomes your Medicare supplement.

Over 65 and never enrolled in Medicare because you didn't have enough Quarters? Everyone can join Medicare and pay an extra premium, even if they don't have 40 Quarters. The Annual Late Enrollment Period is open January 1 until March 31. Once enrolled, your Medicare coverage will be effective the next month. There may be late enrollment penalties for every year since you were first eligible for Medicare.

Age 73: IRS Required Minimum Distributions begin from your Qualified Retirement Plans. This is the mandated Internal Revenue Service minimum withdrawal requirement taken over your life expectancy.

Important Checklist for Medicare and Social Security

Earliest age to apply for reduced Social Security retirement benefits, subject to earnings restrictions if working. Visit: www.SSA.gov for more information.
Start researching Medicare options. Visit: www.Medicare.gov for more information.
Enroll in Medicare. Those who claim Social Security benefits early are automatically enrolled in Medicare. Others need to enroll in Medicare during their initial sevenmenth enrollment period-which starts three months before their 65 birthday-or face lifetime late enrollment penalties.
Full Social Security Retirement age for people born from 1943 through 1954, gradually increasing to 67 for those born in 1960 or later, earnings restrictions disappear at full retirement age.
Those who wait to collect Social Security beyond full retirement age earn delayed retirement credits of 8% per year through age 70. (Spousal benefit does not increase).

Financial Bullets

The beginning of 2023 has seen a few notable financial changes that may affect you and your family.

The new Federal Tax legislation has changed the Required Minimum Distribution (RMD) rules; the RMD changed to age 73 in 2023.

Another significant change is that you can contribute to a Traditional or Roth IRA over age 70½.

If you or your spouse have earned income, you may now contribute to an IRA at any age. The Traditional IRA has RMD requirements at age 73, while the Roth IRA does not have those minimum distribution requirements. In 2022 Nationwide added a 457 Roth option to the Chicago Deferred Comp plan.

If you have a 457 deferred compensation account with Nationwide Retirement Solutions, you may utilize the Loan Provision, available for active and retired officers. The loan is not a taxable event, unlike a regular distribution allowed after you separate service. The principal and full interest can be paid back to your 457 account over a maximum of five years from your personal checking or savings account.

The IRS maximum contribution amounts for 457, 401(k) and 403(b) plans increased in 2023 to \$22,500. Age 50+ catch up \$30,000. The 3 year 457 catch up \$45,000, which is great for those first Time Due checks.

Are you turning 65 soon? Everyone needs to activate their Medicare coverage. Most retirees' City of Chicago medical coverage will end the 1st of the month that they reach age 65. If you have any dependents younger than 65 when you become eligible you will need to obtain them other coverage. Just call Mike with any health insurance questions. If you are still under the Chicago retiree health coverage through a younger spouse, you still need to enroll in Medicare at 65, to avoid any possible late Medicare enrollment penalties. Start researching your Medicare Supplement insurance options before you turn 65!

Medicare Supplemental Insurance (Medigap) is designed to cover the gaps that Medicare does not cover, such as some deductibles, co-payments, and coinsurance amounts for Medicare-approved services. Consider utilizing the Traditional Medicare Supplement plans from United American (Sergeants' Association Group Plan) and Blue Cross Individual Medicare Supplements available through convenient pension fund deductions to maintain the Public Safety Officer Federal tax deduction.

Pension Report

I am sure that just like I am, many of you are interested in the proposed legislation in Springfield permanently removing the birthdate restriction for eligibility at age 55 for a 3% automatic annual increase to the annuities of retirees. While I cannot shed any light on whether or not that legislation will be passed, I can tell you that the Fund and the city have enlisted the services of the actuarial and benefits consulting firm of Gabriel Roeder and Smith & Company to perform a cost impact analysis report for the proposed bill. That report should be completed in the coming month and will be uploaded to the Fund Reports section on the Fund's webpage at chipabf.org. Please stop by the website and check that report out along with all the other valuable resources that can be found there.

As of the March board meeting, the Fund had seen 154 new annuitants for 2023. This is actually a decrease from the same time last year. This is the first time the Fund has actually seen a decrease in the first quarter total since 2015.

I am happy to report that the Fund received the remainder of the City's required contribution to the Fund in March for payment year 2022, bringing the total to \$786,793,000. This was in addition to the \$89,540,000 the City provided the Fund in January. This means that the City fulfilled its obligations for the 2022 payment year and the Fund did not have to file to intercept state funds. As for 2023, the City's required contribution will be \$799,447,000 for the year.

Right around the time all of you receive this report, Chicago will have a new mayor who will very likely appoint new trustees to our Pension Board. Just as the elected trustees have done during my tenure on the Board, we will continue to hold the city and its trustees accountable as fiduciaries to the Fund. The Board has an obligation to ensure the current and future financial health of the Fund and you can be sure that I and the other elected trustees will make certain the city trustees do not forget that. The pension is the most valuable benefit we have as Chicago Police Officers and we must continue to do everything we can to protect it.
