President's Message

Since the last edition of Chevrons, we lost an Active Member, Sergeant Michael Muszynsky and one of our PBPA/PBLC attorneys Retired Lieutenant Joseph Andruzzi. I worked with Mike many years ago when we were both PO's in the old 19th District. I did not get the opportunity to work with Joe while he was still on the job but was fortunate enough to have him as one of our attorneys at the Union.



Both Mike and Joe will be missed by many, I ask that all of you keep them and their families in your thoughts and prayers.

Something that is on everyone's mind is the 5% "Me-Too" issue. As previously stated, all 3 supervisor Unions filed grievances over the City failing to abide by the contract "Me-Too" provision. The Sergeants, Lieutenants, and Captains met with the City on 05 Feb 2024 for a contract negotiation session. Before we started negotiations for the successor contract, we asked the City's team why they were intentionally violating the current standing contract and not awarding the 5% raise for 2024. Their reply was laughable. I pondered to myself why they were wasting their time as attorneys when the stand-up circuit was where they should certainly be. We were told we needed to bargain over the 5% in this round of contract negotiations. Their response does not hold merit as they have given us a 2.5% raise for 2024 without any request or bargaining for it. Regardless of their response, we will be going to arbitration over the matter in June unless they rectify the situation by awarding the full 5% raise and issuing retro checks to all Members affected. I will keep everyone updated on the situation.

Another issue is the pay separation/compression between Sergeants and Detectives. The City sweetened the pot for Detectives but in doing so diminished the Sergeant rank. We will demand that the historical separation be maintained. A big topic is the right to have separation and lengthy suspension cases heard in front of an Arbitrator. Even after getting a resounding scolding by Arbitrator Benn the City still refuses to abide by his award that allows FOP ...Continues on page 2

Members to have an arbitrator hear those cases. I wonder what would happen to this Membership or any other Police Union if we refused to abide by a lawful award from an Arbitrator. More of the same, do as I say not as I do; we see so much from our political class. Rest assured; we will fight for arbitration as it is a right that we are guaranteed in law. And again, as we progress in negotiations, I will keep you as informed as possible.

As spring starts and the grass starts to green, please keep our Active Member Death Benefit Golf Outing in mind. This year's outing will be on Monday, 12 August 2024 at Silver Lake Country Club in Orland Park. All profits from the outing and associated raffles go to the benefit. Registration will open soon, please see the registration form on page 11. We will be posting it on our website, chicagosergeants.org, and mailing it out to our Retirees. Our meetings have been very poorly attended as of late. I completely understand having a million and one things to do. But the Membership is only as strong as its Members. We oftentimes do not know what is happening in the field so the meetings are a great way to inform us as well as the others in attendance of items that can be useful to everyone. The remaining meetings for 2024 are 23 May at 6 pm please note the date change (food truck meeting), 18 July at Noon (cookout meeting), 26 Sep at 6 pm (awards/pizza meeting), and 21 Nov (turkey/gift card raffle) at Noon. Please attempt to attend at least one of the remaining meetings this year.

I recently had the unfortunate opportunity to speak with one of our fellow Sergeants regarding his withdrawal from the Union. He does not see a benefit to Union Membership. That got me thinking, what does the Union offer? Well, just about every good thing the City gives Sergeants is the result of the Union. Before being allowed to unionize and have a bargaining unit to represent us, what benefits did we have? Well we didn't get paid overtime, believe it or not, we only received comp time on an hour-for-hour basis, we didn't have a me-too with FOP 7 or CFD Local 2 Lieutenants, we did not have any protections as far as getting sent anywhere in the City the Dept wanted us to go with no additional compensation, one day you were on days and then two days later you were on midnights, your weekends were coming up, nope, the Commander changed your day off group now wait 6 more weeks for a weekend off if your DOG isn't changed again, there was no bidding for Districts or watches, there was no grievance procedure, no representation when you were involved in a shooting, no representation for BIA (IAD) or COPA (OPS) statements, these are just a minor sampling of the many benefits of being a Member. So, I guess the Union has given the Membership many items most of us now take for granted. Without the Union how many of these items would we still have? Well, the answer is easy, NONE.

Vice President's Report

I strongly encourage Members to become more active in Union activities, attend meetings, and familiarize themselves with the current contract. It is important for members to participate and provide feedback to the CPSA Board of Directors. We are currently in contract negotiations so it is critical for Members to voice their concerns and desires regarding our collective bargaining agreement. The next general meeting is Thursday, 23 May 2024 at 1800hrs at our building located at 1616 W. Pershing. This meeting was changed due to the National Police Memorial in Washington DC. The meetings typically last for an hour or less and food is provided. A list of meetings and events is listed on page 129 of the CPSA handbook.

I also advise Members to regularly check their pay stubs to ensure they are being paid at the correct step rate and salary. When checking the stub please review the pre-tax amount that is listed in the "Earnings" column which does not change on the pay stub. Do not utilize the rate column to determine if you are paid correctly. We are paid bi-monthly the same amount on each check. Our pay differs when we have overtime, duty availability, uniform allowance, or supervisor's quarterly. To compute your actual hourly rate, take your yearly salary amount and divide it by 2080, which is the amount of hours we work in a year.

As a friendly reminder, I would like to inform Members of some information and benefits that are available to them. For those who are unaware, CPSA offers a Suspension Reimbursement Program for Members who are served with discipline. A Member can be compensated for up to five (5) days of suspension time. If interested in that benefit please contact the office and request an application. If a Member is served with a suspension the Member should contact our office to file a grievance. It is important to contact our office when filing a grievance because our grievance proceedings are different from FOP members. The grievance number has to be obtained from the Labor Relations Division and the form we use is not the same as the FOP form. CPD-11.706 is used for supervisor grievances and most units do not have the form onsite. If a grievance is filed on the incorrect form and is not assigned the proper grievance number then it is not a valid grievance. If the error is not caught in time, then a timeliness issue can result in the grievance being dismissed. To avoid this issue, I implore the Membership to call the office for assistance in completing all grievances.

Pension Report

Pension Report By John Lally Pension Board Representative

FUNDING

As of the March 28th meeting, the Fund has received from the City \$461,717,000 of the required payment for tax year 2023/payment year 2024 of the required total payment of \$851,000,000, or 54.26% of the total owed by the City. This puts us on a pace that is ahead of last year when by this time we had received approximately 40% of the total payment owed to us by the City. As I mentioned in the last newsletter, the City made its full payment in 2023 of \$799,447,000. As such, there was no need to file to intercept state funds after the first quarter of this year.

NEW RETIREE/ANNUITANTS TOTAL FOR 2024

As of the March 28th meeting, the Fund had accumulated a total of 128 new annuitants. This is less than the total of 154 we had by this time last year. A drop is noteworthy considering last year also marked a steep drop in the number of retirees from the preceding years. So, it seems the mass exodus has cooled somewhat for the time being. How long that will last remains to be seen.

<u>UPCOMING ELECTION FOR TRUSTEE REPRESENTING RANK OF PATROLMAN</u>

There is an upcoming special election to fill the vacancy for the residual term of the Active Police Member Trustee from the rank of Patrolman, Investigator, or equivalent rank. This vacancy resulted from the retirement of trustee Elmore "Wayne" Metcalfe on 15 February 2024. The residual term will end on November 30, 2024. The election will take place via online voting from 26 April thru 15 May 2024. Of course no Members of the Sergeants' Union are eligible to vote in this election but I bring it up because it is an important position, and the voting turnout the last time the election was held in 2024 was abysmal. Somewhere around 10% of eligible members voted in the election. Please encourage Officers in your units to vote in the election. As I have stated in the past, there is no benefit we receive as Police Officers that is more valuable than our pensions and we should treat it as such. The three candidates running for election are (i)Brock Merck, (ii)Michelle Tannehill, and (iii)Junae Weathersby. I hope that all of the eligible voters will familiarize themselves with the eligible candidates and vote for the most qualified individual.
