

NAPO Legislative Accomplishments

As we celebrate Police Week this May, let me take this opportunity to highlight a legislative accomplishment promoted by the National Association of Police Organizations (NAPO). Last June, by Executive order issued by the President, the Medal of Valor for Public Safety Officers was established. The purpose of the Presidential Medal of Valor is to recognize those public safety officers who have shown extraordinary valor above and beyond the call of duty in the exercise of their official duties. The Presidential Medal of Valor will be presented each year during the commemoration of Police Week.

This is just one among many of NAPO's legislative achievements in recent years. Others include:

- The Police, Fire and Emergency Officers Educational Assistance Act of 1998, which authorizes educational assistance for the dependents of public safety officers killed or permanently and totally disabled in the line of duty after October 1, 1997. It is an expansion of the Federal Law Enforcement Officers Dependents Act of 1996, or the Degan Bill, which was passed in memory of Deputy United States

Marshal William Degan, who was shot and killed in 1992. The expansion covers all public safety officers, which includes law enforcement officers, correctional officers and firefighters. The scholarships would be roughly \$4,485 per dependent per year to cover four years of higher education, adjusted annually based on the cost of living;

- The Bulletproof Vest Partnership Grant Act of 1998 which creates a new program to be administered by the U.S. Department of Justice to assist State and local authorities in providing bulletproof vests to their officers.

President's Message



Dear Fellow Sergeants:

Here it is mid year and summer is upon us, it seems like we were just celebrating the New Year. With the spring and summer seasons comes good news for some of our members. Congratulations to our members who have recently been promoted to Lieutenant, we wish you the best of luck in your careers. I would also like to take this opportunity to congratulate the 153 newly promoted Sergeants and welcome them into our organization; we're looking forward to working with you in the future.

In our November issue I mentioned HB266, the 3% COLA increase at age 55 after one year on pension for those born before 01 Jan. 1950, extending the previous legislation from 1945 to 1950. This Bill has passed both the House and the Senate and is now awaiting Governor Ryan's signature. Hopefully this will happen soon.

BE AWARE OF YOUR RIGHTS

A few months ago during an officer involved shooting investigation a Sergeant was involved as a witness. This Sergeant was denied an attorney during the investigation, both during a statement to detectives and during the round table portion of the

investigation. If you are involved in a shooting investigation, either as the shooter or a witness, you are entitled to legal counsel during this investigation. Your Contract, General Orders and the Police Officers Bill of Rights all provide you with the right to counsel during an investigation of this type. If you are refused an attorney or your attorney is refused admittance to your statement or the round table, get the name(s) of any supervisor who refuses to honor your rights. Also, continue to request counsel throughout the investigation, especially in the round table. Make sure everyone present at the round table is aware that you have requested an attorney. Remember, if you are given a direct order to give a statement use the first paragraph of the disclaimer (pg 118 in the Calendar book) before answering.

INFORMATION FOR THE POLICE

Rumors abound that the Department is preparing to hold a Lieutenants exam, date(s) unknown at this time. It's never to soon to start studying.

The Fraternal Order of Police Lodge 7 and Fire Fighters Local 2 still have not settled their contracts with the City. We wish our union brothers and sisters well in their quest for improved working conditions. That's enough for now; in closing I would like to wish all our members and their families a happy, safe and enjoyable summer. ⚡



Know Your Contract

Department Notice 01-05:

UNUSED 2000 BABY FURLOUGH DAYS & PERSONAL DAYS

This Department Directive deals with unused Baby Furlough Days (BFD) and unused Personal Days (P).

Under the present contract, a sworn member who elected not to use or was denied the use of any BFDs during 2000 may elect to be paid for the number of unused 2000 BFDs or carry over a maximum of four (4) BFDs to be used as days off during 2001.

Sworn members who elected not to use or were denied use of any Personal Days (P) during 2000 may elect to be paid for a maximum of three (3) unused "P" days or carry over a maximum of 2 unused "P" days for use in the following year.

NOTE: Any unused "BFD" or "P" days that were carried over from 1999 to 2000 cannot be cashed in or carried over for time in 2001, as they were required to be used/disposed of in 2000. Likewise, any 2000 "BFD" or "P" days that will be carried over for days off in 2001 **MUST BE USED in 2001** and cannot be further carried into 2002 for days off or money.

You can only bank the time for use in the consecutive year and must use that time in that year or lose it.

Unfortunately a few of our members misinterpreted a similar Department Notice that was issued in January 2000 regarding the unused "BFD" and "P" days from 1999. As a result, they thought they "banked time" on the books which was saved similar to comp time. They did not realize that, in this case it was use it in 2000 or lose it.

Your unit timekeeper is not obligated to inform you of this directive and the consequences of your decision. Hopefully, in October or November your

unit issues a list to all its' sworn members, which notes how many "BFD" and "P" days they have left and to remind them of their options.

If you have any questions regarding your contract that you cannot clarify by reading the contract, contact your Unit Representative or the Office.

As you all know, our present contract expires on



June 30, 2003. The FOP is presently in protracted arbitration with the City regarding the Patrolman's Contract, which has expired for some time now. This arbitration process will no doubt be lengthy.

We have already begun to identify several items for consideration in negotiating our new contract in 2003. We have received suggestions from your Board of Directors and from you, the membership. If you become aware of any issue or circumstance in the present contract that you feel should be addressed in a new contract, or you would like to see something added that you feel will benefit the members, please drop us a line (phone, snail mail or email). Direct your inquiries to the CONTRACT COMMITTEE. We are looking for members who are Attorneys and familiar with contract law to assist us. ⚡

- For fiscal years 1999–2001, \$25 million has been authorized for each year to provide up to 50% of the costs of the vests;
- The Care for Police Survivors Act of 1998 which makes two important amendments to the Public Safety Officers Benefits Act, which was signed into law more than 20 years ago. The Act requires that the Director of the Bureau of Justice Assistance spends at least \$150,000 to enhance national peer support and counseling services for the families of fallen officers and to address the current backlog of cases still pending by the Public Safety Officers Benefits Office;
 - The Taxpayer Relief Act of 1997 which includes federal tax free survivor benefits for public safety officers killed in the line of duty, exemption from federal taxes for heart and hypertension benefits, a permanent moratorium on application of certain nondiscrimination rules of state and local governments and the removal of the dollar limitation on payment of pension benefits;
 - The Small Business Job Protection Act of 1996, which includes important revisions to Internal Revenue Code Section 415, providing protection for public sector employees' retirement benefits, and revisions to Internal Revenue Code 457 increasing the amount public employees can contribute to their 457 deferred compensation plan and protecting worker monies from employer abuse;
 - The Source Tax Bill of 1996 which prohibits states from taxing the retirement income of former residents whose pensions were earned in that state;
 - The Violent Crime Control and Law Enforcement Act of 1994, omnibus anti-crime legislation;
 - The Family Leave and Medical Act of 1993;
 - The Law Enforcement Family Support Act, which provides funds for law enforcement stress research and training;
 - Legislation in 1998, which raised the Public Service Officers' Benefit for officers killed in the line of duty from \$ 50,000 to \$100,000 plus annual cost of living indexing. Today the Federal Death Benefit is \$146,946;
 - Legislation in 1998, which prohibits implementation of an Internal Revenue Service proposal to tax-accrued public employee leave as current income;
 - Prevention of the curtailment of adoptive asset forfeiture payments to the states by the Federal Government
 - Effective and equitable provisions of the Fair Labor Standards Act (FLSAA) Amendments of 1985, which implemented the United States Supreme Court's decision in the Garcia case, upholding the constitutionality of the Fair Labor Standards Act to non-Federal public employees.

The legislative issues affecting the vital interests of police officers continue to grow daily as crime, drugs and law enforcement issues occupy more time of Congress and the Administration. Working independently and with other police, public employee and employer groups, NAPO has achieved a number of solid legislative accomplishments for its constituents. It has also defeated efforts that would seriously undermine law enforcement interests. These are merely illustrative of the areas where police participation through NAPOI has made and continues to make a difference. 

Grievance Corner

The numbers of grievances for 2001 appear to be along the same line as in 2000 with one major exception. The current grievances appear to be more in tune with contractual violations. As a result the union is demanding more arbitration hearings and is less likely to withdraw any grievances.

As published in the Chicago Sun Times this past April, the Lieutenants' Association and the Sergeants' Association collectively filed grievances with the Management and Labor Affairs Section pertaining to the treatment of supervisors in one of the south side Districts.

In addition, an E.E.O.C. complaint with the charge of discrimination has been filed. Rather than passing on our opinion we will leave it up to the judicial system for a decision. Whatever the outcome, it took a lot of courage for the six (6) supervisors to come forward and voice their complaints.

Recently we received a phone call from a newly retired sergeant that had been on the medical roll for a period of time just prior to his retirement. When the sergeant finally retired he was compensated for three (3) unused vacation days. According to his personal records, he had nine (9) unused vacation days. A grievance was filed and during the initial investigation it was discovered that while on the medical roll, his unit changed his day off group without his knowledge, thus affecting a furlough that he had been

placed on. During a Step 2 hearing, the union was able to restore six (6) days of unused vacation time to the retired sergeant. The retiree was glad to hear "The check is in the mail!"

N.A.P.O., Washington DC

The reporting Sergeant attended the N.A.P.O. Legal Rights and Legislative Seminar in Washington D.C. on May 10th thru 12th of this year. Representatives from various Law Enforcement Agencies throughout the U.S. were in attendance.

A Legislative Agenda regarding pending Bills that effect Law Enforcement was held and those present took that agenda forward to Capitol Hill. Among the Bills of interest were:

1. H.R. 1626/State and Local Law Enforcement Discipline, Accountability and Due Process Act of 2000
2. Continuation of Community Oriented Policing Services (COPS PROGRAM) "PROTECTION ACT"
3. Mandatory Social Security Taxes on Public Safety Workers
4. Public Pension Reform, H.R. 10/ S. 742
5. Public Safety Employer/Employee Cooperation Act/ H.R. 1475
6. Public Safety Officers Benefit Program, and
7. Right to Carry/ H.R. 218

It was interesting to learn that 23 States do not have any Collective Bargaining Rights and that in two of these states, it is UNLAWFUL for management and labor to talk!


Issues such as the "Social Security Pension Offset" were also addressed. It appears that Congress is not of a mind to cease this practice. However, there was interest in a proposal to give those affected by the "offset" a Tax Credit. It falls short of replacing our earned benefits but it is a start if this concept receives more support. NAPO is against mandating that some or all of state and local government employees, including newly hired ones, and their employing agencies be required to pay Social Security taxes.

The COPS Program, which has run its six-year course, is about to expire. Legislation has been introduced to continue the COPS Program for an additional 6 years.

Legal Rights issues were also discussed during the Seminar. Topics included:

1. An Officers right to engage in off-duty conduct or employment and departmental efforts to discipline for such activities.
2. Labor organization's responsibilities in representing officers making or defending against allegations of sexual harassment or of gender or race discrimination.
3. Will the Bush administration change or continue current Department of Justice, Civil Rights Division policies affecting the police?
4. Disclosure to defense attorneys or the press of information from officer personnel files, internal affairs investigative files or administrative or court records concerning officers.

The seminars were very informative. Lt. Joe Fitzsimmons of the Chicago Police Lieutenants Association/P.B. & P.A., participated in leading two panel discussions. The seminar had the additional benefit of opening the door to networking with various other Law Enforcement "Unions" and bargaining units. 



National Law Enforcement Officer Memorial

Washington, DC • May 2001

Approximately 200 sworn members from all ranks of the Chicago Police Department paid their respects to their fallen comrades in Washington DC during National Police Week this past May.

This year's ceremony witnessed the addition of 313 Law Enforcement Officers' names to the Memorial Wall. Of these, 150 died in the line of duty in 2000.

Among those honored fallen officers was **Sergeant Alane M. Stoffregen**, Chicago Police Department Marine Unit, whose "End of Watch" came on 02 June 2000 during a tragic on-duty training dive. Stoffregen's name is now inscribed on the Memorial among the 15,448 others who died in the Line of Duty in the United States.

On Sunday, 15 May, a candle light vigil was held at the National Law Enforcement Officers' Monument. Approximately 15,000 officers and family members were in attendance at this ceremony.



Memorial plaque and carved inscription honoring Sergeant Alane M. Stoffregen who died while on-duty in 2000.






Delay in Medical Treatment

The Union has received numerous complaints from Sergeants who have been on the medical roll, I.O.D., and did not get the medical treatments they were entitled to in a timely manner. This has been primarily due to the fact that the Medical Section will not approve treatments until the Committee on Finance classifies them as injury on duty. Also, the Medical Section has delayed tests/treatments ordered by their own doctors (in some cases for weeks) because they again wait for the okay from the COF for these procedures, even though the injury had already been classified as IOD. In order to get the necessary medical tests/treatments they require, many Sergeants have been forced to get them on their own and submit the bills to their

private medical insurance carrier for payment.

Under the Pension Code, the City is to provide proper medical care and hospital treatment for any policeman injured on duty. In addition, the City is responsible for the payment of the medical care and hospital treatment provided to the officer. Accordingly, it is the City's responsibility to provide payment for any medical expenses and not your private medical insurance carrier. We are requesting that any Sergeant who has been injured on duty and was delayed or denied medical tests/treatments to please contact the Union. The Union intends to aggressively address the current, unacceptable, Medical Section procedures that are in place! ⚡

Bidding Alert

If you participate in an “Inter-District” (City-Wide) bid process, YOU are responsible for the forwarding/distribution of the P.A.R. form. After you have your Commanding Officer/Watch Commander sign the form set you must ensure that:

1. The white copy is sent to the unit that you are bidding for,
2. The pink copy is sent to the Personnel Division, Employee Development Section,
3. The green copy is sent to the Union, Unit 545 and,
4. You retain the gold copy.

The best way to accomplish this is:

- A. Fax a copy to “steps” 1,2 & 3 and contact each of them to verify that they have received the fax (GET A NAME!), and
- B. Forward the form set copies to the designated units via the Police Mail.

Another alternative is to “hand-carry” the copies to the designated units.

Again, it is YOUR responsibility to see that the designated units receive their copies! ⚡


