President's Message

With 2008 well under way there are several important issues that we have been addressing on behalf of our members. We remain in contract negotiations with the City and Department. We are making progress on several key issues in an effort to bring these negotiations to a close with the ultimate goal of being able to present a contract to our membership for ratification. Thus far we have made progress on issues concerning health care and discipline. We are currently discussing economic and operational issues, as well as the length of the contract. The current state of the economy and the various command changes within the Department along with recent policy changes have made negotiating this contract a tedious and daunting task. All parties mutually agree that it is in everyone's best interest to reach an agreement as expeditiously as possible. We remain committed to attempting to resolve our differences with the City, but we will not agree to anything that we feel would adversely affect our member's current contractual protections and benefits.

We continue to address the problems that have plagued this past lieutenant's examination process and current promotional list. It remains our position that this testing process was unfair and that the City's blatant disregard to properly address the concerns raised by the participants leads us no choice but to pursue our position in court. Along with our attorneys we have developed a course of action that ultimately will lead us into Federal Court.

Since I last reported to our members, I have had an opportunity to speak briefly with Superintendent Jody Weis and express some of the concerns of our

Pension Report: Explaining The Two Automatic Increases

It's Not A "COLA"!

There always seems to be a lot of confusion concerning the automatic increase in the annuity. Many mistakenly call this the "COLA" (cost of living adjustment), which is a misnomer in that a "COLA" is tied to inflation, while the automatic increase is not.

There are two different automatic increases that apply to Sworn Retirees. I will attempt to clarify this, all of which is covered in the Illinois Compiled Statutes, under section 5-167.1. - Chicago Police Pension Act.

The automatic increase started September 1, 1967. For retirees with at least 20 years of service credit the automatic increases are 1.5% of the original annuity, commencing at age 60, or the first anniversary of retirement, if later, to a maximum of 30%. This means you only get the 1.5% increase for 20 years. This automatic increase has been enhanced for retirees born before January 1, 1955, but as of now the above automatic increase applies to anyone born after January 1, 1955.

On January 1, 1983, the automatic increase was improved; it was increased from 1.5% to 3%. The age you qualified for the automatic increase was lowered to 55 from 60.

The last change was made in December/November of 2005, and reads: "A retiree born before January 1, 1955, who is retired with at least 20 years of service, receives an increase of 3% of the original annuity, starting on the first month following the first anniversary of his retirement or the first month following the first anniversary of his retirement following the age of 55, whichever is later."

This automatic increase must be passed every 5 years in the state legislature, so, hopefully the automatic bill will pass before 2010, so all retirees born

before January 1, 1960 will be eligible for the 3% increase. Also, unlike the 1.5 automatic increase, the 3% automatic increase is "forever," meaning you will get the increase every year (unlike the 1.5%, there is no maximum of 30%).

Some Examples:

Example #1 - An officer born before 1 Jan 55 retires at age 50 with more than 20 years of service. He must wait until his 55th birthday before he is eligible for the 3% automatic increase.

Example #2 - An officer born before 1 Jan 55 retires on his 54th birthday with more than 20 years of service, after thirteen months, he receives the 3% automatic increase.

Example #3 - An officer born before 1 Jan 55 retires with more than 20 years service on his 58th birthday. He will be eligible for the automatic increase in thirteen months.

The Double Bubble

It is possible to get two automatic increases within two months and this is referred to as the "double bubble." You must be 54 or older, with at least 20 years of service. The shortest wait for the double bubble is for you to retire on November 29. The following December you will get the 3% automatic increase, and a month later, you will get another automatic increase of 3%. Many think they will get more money if they retire in January because they will pick up furlough days, personal days, pay increases, etc. But, most probably, you will make more money in the long run if you retire in November and get the two automatic increases within a two-month time-span.

Keep in mind that once you retire, you are no

The benefit of \$3,000.00 is given without the beneficiary filing any claim forms and at a time when it can be used the most.

Grievance Report

The following is a snap-shot of the grievance procedure. Hopefully the information will be helpful and give some insight into what filing a grievance entails. The grievance procedure is a form of checks and balances between the PB&PA Unit 156 and the city with regard to our contractual rights. Not all issues of fairness are grievable however. A violation of the sergeants' contract must exist. Research the contract and know what sections were violated prior to seeking any form of resolution. Any sergeant can call the association office for advice or assistance. An attempt to resolve the dispute must be made within ten days of the circumstance that led to the dispute. Should any sergeant feel that his/her contractual rights have been infringed upon, he/she should first attempt to resolve the dispute with the first exempt member in their respective chain of command by presenting a completed PB&PA Grievance form. Many grievances related to discipline are called "Just Cause Grievances". Section 8.1 of our contract basically states that no sergeant shall be disciplined without just cause. This should be noted in the narrative of the grievance report, along with the request that the contract be made whole and that all rights and benefits of the sergeant be restored.

Once the problem is brought to the attention of the exempt member, the sergeant should get a response within ten working days. If the dispute cannot be resolved at this informal step, the exempt member will contact Management and Labor Affairs and a grievance number will be provided. Once the Grievance form is forwarded to Management and Labor Affairs, PB&PA Unit 156 will be notified. The grievance committee will determine the validity of the grievance, and then make every attempt to mediate a remedy. If both parties come to an agreement, the grievant sergeant will be contacted for his or her approval, and the grievance will be settled. However, if both parties reach an impasse, a summary opinion may be requested. In this step, the grievance is sent to an arbitrator to review

and render his opinion as to what he would find if the grievance was brought to full arbitration. The opinion of the arbitrator is not binding at this point. Most cases are decided by summary opinion due to the tremendous costs involved with arbitration. The grievance committee will weigh each case and determine whether or not to take a grievance to arbitration. The finding of an arbitrator, at this step, is binding on both parties and the grievance would thereby be resolved. If a dispute should arise, I hope that the above information will assist you. 🏠

Chicago Police Football

Before You Turn 65

It is very important that you contact the Social Security office **AT LEAST 3 months before you turn 65**. The Pension Fund needs AT LEAST 30 days after you give them your Medicare information to make the necessary changes. It takes the City at least 2 weeks to get the information to BC/BS who will send you new identification cards with a new group number on it. Also, make sure that you have ordered any medications you use prior to this change to avoid problems. It's best to make an appointment with the Social Security office to save time. They also have a lot of information online. It's hard to believe, but they are very helpful. 🙏

Federal Rebate Checks: When Will You Get Yours?

The IRS has announced that it will start sending the economic stimulus tax rebate checks starting on May 2, with the first round of weekly payments to be completed by early July. Rebate check direct deposit or mailings will be made according to the last two digits of your Social Security numbers as follows:

Direct Deposit: Depending on the last two numbers of your Social Security Number, your rebate should be deposited by:

- 00-20: May 2
- 21-75: May 9
- 76-99: May 16

By Mail: Depending on the last two numbers of your Social Security Number, your rebate check should be mailed by:

For married taxpayers who filed a joint return, the first Social Security Number on the return determines the mailing date. Retirees who no longer file a income tax return will not receive a check. You must file to be eligible. 🙏

Have Older TVs? Big Change Coming

Effective February 2009, all TV stations will broadcast only in digital TV. This means that if you do not have a High Definition TV you will not be able to watch television.

If you watch your television or tape a show with a VCR using cable or a satellite dish this will not apply to you.

If you have the older TV sets you will need to purchase a DTV Converter for each TV that you intend to use. If you use a VCR to tape a program while you are watching your TV, then you will also need a DTV Converter for the VCR.

The US Government is making available to each household, two free \$40 coupons to be used toward the purchase of a DTV Converter. Once you receive these

coupons they are only good for 90 days. The DTV Converters are available at Radio Shack, Best Buy, and possibly other stores. They list for \$60.00. Using the coupon, you will pay \$20.00 for each converter. They contain all the wires and connectors you will need. Actually, they install rather easily.

If you have an older TV, then you must be using an outdoor antenna. You can use the same antenna; there is no reason to change it.

There are two ways to request a coupon. You can call 1-888-388-2009 or go on line to www.dtv.gov. It is suggested that you start this process soon, because knowing the government, they may run out of coupons, or there could be a shortage of converters the longer you wait. Good luck. ☺
