**Dedicated to the memory of Officer Richard M. Francis # 5276
Killed in the Line of Duty — 02 July 2008**

On behalf of the Chicago Police Sergeants' Association I would like to extend our condolences to the family of Officer Richard Francis #5276, who was killed in the line of duty on 02 July 2008. Officer Richard Francis leaves behind his wife and two step-daughters.

During the early morning hours on July 2, 2008, Officer Francis was on patrol in the 019th District when he was flagged down by a C.T.A. bus driver requesting assistance for a disturbance on the bus. On this particular midnight shift Officer Francis was working alone. Officer Francis requested assistance, but he did what the 27 year veteran had done so many times before in his career - he acted and responded to a call for help. Officer Francis confronted the offender before assist units arrived. During the struggle Officer Francis was fatally wounded by the offender.

So many times Police Officers are criticized by the media, citizens, politicians and at times even our own Command staff. Somehow day after day, officers like Richard Francis just keep doing their job without any accolades, acknowledgments or even a simple "thank you" from these same people who are quick to criticize, but even quicker to call the police for help. ° Officer Richard Francis was proud to be a Chicago Police Officer and for over 27 years proudly wore the uniform of a Chicago Police Officer.

2008 Board Elections

The three year term of office for all Chicago Police Sergeant Association Board members expires after the election, just prior to the first Executive Board meeting of the new year. Terms for the newly elected officers begin with the first Executive board meeting of the year, which is 15 January 2009.

Pension Report

As of June 15 2008, there were a total of 190 sworn personnel that have retired. Below is the breakdown by rank:

P.O - 146

Sgt. - 25

Lt. - 5

Capt. - 5

Exempt Rank - 9

The last two years have been below the usual average of 400 retirees a year. For the year 2006, the total retired was 328 and the total for 2007 was 336.

It has been a tough year for investments. The 1st quarter of this year was terrible. April and May were much better. As I have mentioned before, the Fund is moving into more alternative investments, including real estate and infrastructure. The asset allocation of the Fund as of May 31st is as follows:

U.S. Stocks - 44.1%

International Stocks - 18.0%

Bonds - 30.2%

Private Equity - 5.3%

Real Estate - 1.8%

Infrastructure - 0.4%

Cash - 0.2%

New PABF Computer System

The Retirement Board is developing a new computer system for tracking participant's employment and contribution histories and to calculate and administer benefits. The new system will replace Wypen, a Windows-based computer system developed by the Fund's actuaries in the mid-1990s. Changes in technology as well as legislative changes to benefit formulas have taken their toll on the system, which is no longer able to support the calculation of some benefits without significant manual effort by staff. The new system will address these gaps in benefit calculation capability, as well as establishing an updated hardware and software platform based on modern internet technologies. While no changes have been planned as of this time, the new platform creates opportunities for additional functions to be made available to members through the www.chipabf.org website.

Beginning in September 2007, the Board's staff began working with a team from Bradley Consulting Group to identify system requirements. Computer

software programming began in January 2008, with rounds of testing slated to begin in July. A formal acceptance test period with Board staff simulating their daily operations using the new system will begin in the fourth quarter of 2008 and continue through year end. Implementation of the new system is planned to coincide with processing the initial city payroll files in early 2009.

Bradley was selected by the Board's staff to implement the new system based on its experience with pension funds as well as government and non-profit organizations in Illinois. Principal consultants on the team have designed and implemented computer systems for the Chicago Teachers Pension Fund (CTPF), the Illinois Municipal Retirement Fund (IMRF), and State Universities Retirement System of Illinois (SURS), as well as additional work for the State of Illinois.

The Retirees' Corner

If you haven't read or heard about it yet, the U. S. Supreme Court overturned the Washington D. C. ban on hand guns. This will directly affect Chicago's gun registration ordinance. A retired Sgt. recently purchased a replacement weapon for an inoperative one and the City of Chicago refused to permit him to register the new one. The Sgt. was qualified under the Federal SB-218 law which should have taken precedent in his case. The Sgt's case is currently at the appellate court level; however, it is certain that the Supreme Court ruling will affect the case. Mayor Daley in comments to the media stated that he would fight the Supreme Court ruling. I thought that the Supreme Court was the highest court in the land?

Retirees and active officers have to watch out for our Pensions. Sen. Nancy Pelosi of California, Speaker of the House, wants to tax our pensions, 401Ks, mutual funds, and more. There was a bill introduced in the Illinois Legislature last year that wanted to tax our pensions, but it was stuck in committee.

Recently the Chicago Sun-Times published a report suggesting to our Governor that pensions should be taxed as a way to fund the state budget. Again recently, Mayor Daly convened a panel of 32 people to review the City's pension system. Recently, Mr. Dana Levenson chairman of that panel, apparently violating a confidentially agreement that all members had to sign, stated to the media that they are looking to recommend that the pension system be replaced by 401K's especially for new employees. If you have never taken an interest in voting or writing your elected public official I suggest you start now.

The Retired Chicago Police Association of Chicago has new offices. They have moved from the office located on the south side at 65th and Pulaski. They are currently located on the north side with the Chicago Police Credit Union. The address is 5310 North Harlem; phone 773-763-5310.

Pension Board elections are coming up in October of this year. At this point I can only give you my recommendations and opinions. Sgt. Michael Lazzaro has represented the active duty Sergeants for the last three years. He has done an excellent job. While his predecessors did a great job, Mike has gone above and beyond. Mike is out there visiting roll calls at districts and units, and he's there on weekends and will visit any watch. Mike was the only one who voted against giving real estate investments to a political friendly firm. My support also goes to Ken Hauser who represents all of the current retirees and annuitants. Ken is outspoken and knowledgeable and is someone who we need in these up and coming difficult times.

The 2009, Corned Beef Dinner honoring the Sergeants who retired this year "2008" will be at the Hanging Gardens Banquet Hall, located in the mall at Belmont and Cumberland. The date is Thursday the 19th of February 2009. Make a note of it.

We are welcoming two Board members to the ranks of our retirees, Sgt. George Whiteside who stayed to the bitter end, and Sgt. Ed Brennen. Good luck to both of you.

Retirees' Concealed Carry

There have been several inquiries made to our office relative to applying to IROCC (Illinois Retired Officer Concealed Carry) for the right of a retiree to qualify and carry a weapon.

At the present time you must be a RETIREE before you can submit an application. However, after conferring with the Chicago Police Pension Office, it is their position that if you turn in your application for pension, PAR form, and exit interview in person at the Pension office, then you may submit an IROCC application at the same time and initiate your qualification process. This is true even if you still have a few days to work prior to your termination date.

There has been some speculation that HR 218

enables you to carry a weapon for 12 months after you retire. The State of Illinois will allow this if you can provide written documentation from your police agency, and that extension would be 12 months from the date you qualified with your department. I have never heard of the Chicago Police Department providing any such documentation.

Other states have different fees and procedures; however, residents of Illinois must abide by the current regulations. There is a link to the IROCC.ORG application process on our website. The range officers at the Will County Sheriff's range, which we use, are great. Good luck. 🏠

Illinois Scott's Law

It's Illinois Vehicle Code-625 ILCS 5, Section 11-907, and it requires all vehicles to pull over to the right and stop until the emergency vehicle passes. We as the police all know this. This law was named after a lieutenant who was killed by a drunk driver while at the scene of an accident on Chicago's Dan Ryan Expressway. Therefore, section C now states "when approaching a stationary authorized emergency vehicle with flashing red, red and white, blue, or red and blue or amber or yellow warning lights, the driver shall pull into the adjacent lane (at least 2 lanes away if possible) and reduce speed, proceeding with caution. (The vehicles with yellow flashing light would include authorized service vehicles.)

Several other states have similar laws so be aware. Now here's the unique teaching fact regarding this law. It is not uncommon for another police vehicle to be parked a short distance down the road. If the first patrol vehicle notes a violation they will radio the patrol vehicle down the road, and you will be stopped and ticketed. The minimum fine is \$100 dollars with a maximum of \$10,000. So be aware of the above and tell your family and friends. The law is there not only for your safety but the safety of our fellow law enforcement offices and the people who maintain our roads.

One other fact. That 45 mph in a construction zone, will you can be ticketed even if there is no construction work being done or workers present. Happy driving if you can afford the gas. 🏠

The age old question keeps coming up as topic of conversation, 'why do bad things happen to good people? I don't have the full answer but one thing I know for sure, "Things aren't always what they seem." Let me explain with a short parable.....

Security Augmentation Program

The Chicago Department of Public Health (CDPH) is developing plans to preemptively respond to any public health crisis, natural or man-made, that impacts Chicago. Plans include a city-wide mobilization of resources for the mass prophylaxis of the city's residents. Security is a consideration that has to be addressed and the CDPH has recognized the potential offered by **retired law enforcement personnel**. Federal guidelines for developing security plans have included utilization of retired police officers in pandemic influenza and bioterrorism response plans. The CDPH recognizes the tremendous potential that exists in Chicago's pool of retired officers and is looking to develop plans to utilize that potential.

As a first step the CDPH would like to register those **retired officers** who would be interested and willing to provide their services in the event of a public health disaster. Benefits have not been established or determined at this point, however one benefit that is definitely being considered is the inclusion of **these volunteers in the category of "first responder" and "emergency responder" and, as such, they will receive preventive medication for themselves and their spouse and families before mass distribution is initiated.**
