Their service to the C.P.S.A. will be greatly missed, but we are counting on them for their continued involvement as retirees. Also our Financial Secretary, Dennis Hinkson who has not yet decided on retirement chose not to seek re-election to the C.P.S.A. Executive Board. Ed, George and Dennis, thank you for your tireless efforts and dedication to the Chicago Police Sergeants' Association. This year we lost our friend and longtime Board Member, Michael Stather. Mike passed away in October after a long illness. Mike most recently represented the north side retirees and was instrumental over the years in making the golf outing the success it is today. All proceeds from this golf outing go directly into the death benefit account for our active members. Mike you will be deeply missed.

I would also encourage all those that were promoted to the rank of sergeant this past year to take an interest in the Association. It is through the support of our members that the Association remains viable and can continue to represent the interest of our members.

Last year was a challenging, but productive year. We began 2008 with ongoing contract negotiations. We've held numerous meetings this past year with the City and have made significant progress, but there are several important issues that still need to be resolved. I am sure that you are all painfully aware of the current economic conditions that have affected all of us to at least some extent. This economic situation has had a major impact on our negotiations and being able to secure a contract that our

members rightfully deserve. It is my sincere hope that in 2009 we will be able to bring a contract to our members for their review and ratification.

In 2008 we bid farewell to Superintendent Phil Cline and welcomed incoming Superintendent Jody Weis. I have had several conversations with Superintendent Weis and several members of his Command. Superintendent Weis has been very willing to listen to our suggestions and has actively sought our input on issues that directly affect our members. While I and your other elected Officers of the C.P.S.A. have not always agreed with the Superintendent, we applaud his efforts to maintain an avenue of communication.

Since Superintendent Weis took over, the Department has undergone two major reorganizations. In an organization as large as the Chicago Police Department it is no surprise that some of these changes have impacted our members. I, along with your elected Officers remain committed to ensuring that your contractual rights are maintained.

Throughout 2008 we continued to challenge the City's position over the promotional examination process by filing a lawsuit in Federal Court. The City's position is that the examination and merit process is fair and completely open. One only need ask that if this process is fair and open then why is the eligibility list kept such a secret and the C.P.S.A. is denied access to this list to ensure fairness and compliance with the merit promotion process. This process is extremely troublesome and only leads to skepticism and further demoralizes those who put forth their best efforts when preparing for these infrequent exams. If the City is really interested in promoting the most qualified and experienced individuals to serve the citizens of Chicago, then the testing process needs to be completely overhauled.

With the efforts of our current Grievance Chairman, Jim Ade and our previous Chairman Jim Cosgrove, along with our Attorney Bob Kuzas and the addition of Attorney Joe FitzSimmons to his staff we have made significant progress in how we handle the grievance process. Grievance Chairman Jim Ade has completely overhauled how we track the progress of grievances. He maintains almost daily contact with M.L.A.S. and our attorneys in order to address our concerns in a timely manner. By revamping how we

internally address and follow-up pending grievances and address potential situations that could possibly lead to a grievance, we have been able to resolve many of these issues in a more efficient manner. During the latter part of 2008, the C.P.S.A. was awarded a major victory through an arbitrator's decision. A few years ago the C.P.S.A. filed a grievance on behalf of several of our members who were detailed out of their Areas of assignment and were not compensated properly per the contract. The arbitrator's decision resulted in a significant monetary award for our affected members.

During 2008 the C.P.S.A. along with the Captain's Association, Lieutenant's Association and the F.O.P. held joint meetings with the Department over implementing several different pilot work schedules beginning in 2009. The proposed pilot work schedules were reviewed by the C.P.S.A. Board of Directors and unanimously approved. These pilot programs will be in effect for one year. The C.P.S.A., along with the F.O.P. and the Department has agreed to meet monthly to discuss any issues that arise within these work schedules. The important provision is that no single program can be eliminated or permanently implemented during the year unless both sides agree. I urge any member working in or affected by these pilot programs to give the C.P.S.A. your feedback, whether it is positive or negative. Without your input we cannot evaluate these pilot programs effectively.

During 2008 all of the positions within the C.P.S.A. were up for election. The contested positions were for President and four Director at Large positions. Congratulations to the four candidates elected to the position of Director at Large; Debra DeYoung (re-elected), Nancy Higgins (re-elected), Michael Lazzaro, who previously served as the Area Four Director and Michael Burke. Also, congratulations to Michael Lazzaro on his successful re-election as Trustee to the Retirement Board Policemen's Annuity and Benefit Fund. The following new Board Members were elected by acclamation, John Stahl (A/1 Director), Mark McDermott (A/3 Director), Tom Flaherty (A/4 Director) and Thomas Linnane (A/5 Director).

I also faced a challenge in my bid for re-election as President of the C.P.S.A. I would like to thank all those members who voted for me and believed that I deserve to represent them as President of the C.P.S.A. To those members who chose not to cast their vote for my re-election it is my sincere hope that during the

upcoming term I can earn your support. Election challenges and campaigns can serve a positive purpose. They provide an opportunity to hear the concerns of the membership that otherwise may not be voiced. While some of the information disseminated about me was not completely factual, I commend my opponent, Gerard Majerczyk for bringing some important issues to the forefront. I appreciate Gerry's magnanimous congratulatory comments and posting after the election regarding not only my re-election, but to the entire elected C.P.S.A. Board

By now all active members should have received their 2009 calendar books and decals. If you have not received yours, please contact the C.P.S.A. office or any Board Member. Thanks to our Membership Chairman and Vice President, Robert Kirchner and South Side Retiree Representative, Don Januszyk for their efforts in designing and compiling the 2009 Calendar Handbook. This was a tremendous volunteer effort on their part during the holiday season to get over 1,300 books out to our active members.

As I stated during my re-election campaign, I along with the rest of the elected Officers of the Chicago Police Sergeants' Association are accountable to you. We have been entrusted to represent your interest and ensure that your contractual rights are protected. With your continued support, I look forward to a very positive and progressive 2009.

# Pension Report

## **"EVERY TIME YOU WIN, YOU'RE REBORN; WHEN YOU LOSE, YOU DIE A LITTLE"**

Thanks to everyone who voted to re-elect me as Trustee for the Pension fund and as Director at Large on the Sergeant's Association Board. I have been on the Pension Board since 2005 and on the Sergeant's Board since 2000. It is a pleasure to serve on both of these Boards.

## **A TRULY EGREGIOUS YEAR FOR INVESTING**

The headlines are bleak. It has been the Stock Market's third worst year in more than a century. Only 1931 and 1907 were worse. The Dow Jones Industrial average lost 34% this year. Of the 30 stocks in the "DJIA" only two had positive returns. Wal-Mart was up 18% and McDonalds was up 6%.

The year 2008 was the worst investment return the Fund had in recent history. Previously 2002 was the worst with a return of negative 7%; however 2008 shows an un-audited return of negative 27%. International stocks at negative 46% and U.S. stocks at negative 27% were the biggest laggards in the Fund's Investment Portfolios.

## **RETIREMENTS FOR 2008**

Once again the amount of retirees was below the historical average of 400. For the year 2008, 340 sworn members retired, compared to 336 in 2007, and 328 in 2006. Here is the break down by rank:

**Police Officers - 257**

**Sergeants - 51**

**Lieutenants - 10**

**Captains - 9**

**Exempts - 13**

## **PENSION PORTABILITY**

The Pension Portability Bill was passed on November 20, 2008. As of the first week of January 2009, the Bill SB 2520 has not been signed by the Governor. You can go the Pension Fund's website for more information.

There are a group of sworn members who attend the Pension Board meetings every month. Carlos Saladino has been attending the meetings for more than eight years. They have improved communications between the Fund's staff and the appointed Trustees, and have shown the commitment active members have for their Pension. All Sergeants should try to attend at least one Board meeting before they retire, there is strength in numbers. ## Saying It Again!

---

PLEASE make sure that your beneficiary information is up to date. If an active duty Sergeant dies the listed beneficiary receives a check from our unit and also the state PB&PA unit. When the Sergeant has failed to list a beneficiary, then it is only through the efforts of your Board members that an appropriate family member is identified and a check issued. In a previous death we were unable to act because of legal issues.

Usually, the newer Sergeants are in compliance because we make sure they have both the local and state beneficiary cards. A veteran Sergeant can call our office and check to see if they have a card on file and it is up to date. At your request we can send both cards to your unit for you to fill out.

This advice applies to your pension and city benefits also. If a current beneficiary is not listed, your hard earned benefits can go up in smoke or it can cost your family in legal fees. Take the time to make sure you have it all together. You never know who can be knocking on your door. 🏠
